


UNEMPLOYMENT INSURANCE CONTRIBUTIONS ACT, 2002 APPLICATION FOR REGISTRATION

- 1. This is to confirm that you are now registered with the Fund as an employer. Your reference number that must be used in all correspondence with this office is as indicated above.
- Contributions are payable monthly and payments must reach this office within 7 days after the end of the month for which contributions are due. For example: Payment of contributions due for January, must reach this office on or before 7 February, etc. Important: To avoid unnecessary 2 benalties and interest, please ensure that your payments reach the Fund within the prescribed period.
- 3. Section 9(5)(a) of the Act also provides for payment of the full amount of the total contributions in respect of a financial year in a single payment within 7 days after the beginning of that financial year, subject to the following conditions:
- The total contributions due must be made within the boundaries of a financial year or liability period. "Financial year" or "liability period" means the period commencing on the first day of March in any year, or from the first day of liability providing such a date falls within a current financial year, and ending on the last day of February in the following year, or the last day of liability providing such a date falls within a current financial year. 3.1 vear.
- 3.2 The employer may not deduct the employee's share of the total contributions due "up-front". Deductions must still coincide with intervals of payment of remuneration.
- 3.3 If the amount of a payment already made is less than the amount that should have been paid, the employer must as soon as possible pay the outstanding amount. Arrear contributions may not be deducted from the earnings of an employee.
  3.4 If it subsequently becomes known to the employer that any payment made was not due or payable, or was in excess of the amount due or
- payable, the employer must refund to the employee such amount or excess amount as has been deducted and overpaid by the employer, despite the amount not having been refunded to the employer by the Unemployment Insurance Commissioner. Such refunds must then be claimed from the Unemployment Insurance Commissioner on an annual basis and after the end of the relevant financial year.
- Permission to pay other than monthly or annually up-front cannot be granted. Where the 7<sup>th</sup> day is not a "business day", payments must be made on or before the last "business day" prior to the 7<sup>th</sup> day. "Business day" means any day which is not a Saturday, Sunday or public holiday. 5
- A penalty of 10% as well as interest at the prescribed rate are payable on all overdue or underpaid contributions. 6


